 Please instruct remitting banks to send the payment instruction to us (HSBCMOMX) by SWIFT MT103 with \*the following details.

• If remitting banks cannot send their payment instruction to us (HSBCMOMX) directly, please instruct them to make arrangement with any of our #Group Offices/Correspondent Banks to send their payment instruction to us (HSBCMOMX) by SWIFT MT103 with \*the following details.

#### Reference 1:

If you want us to credit the remitted fund to your respective foreign currency savings sub-account in your integrated account, please provide your account number with suffix 151. On the other hand, if the suffix of a MOP or HKD current account is specified, i.e. account with suffix 001 or 101, and the currency of remitted fund is different from

the currency of the current account, the remitted fund will be converted and credited to your current account at the prevailing exchange rate.

## Beneficiary account number crediting an integrated account in HSBC Macau as below:

 Foreign currency savings account, i.e. account with suffix 151 (For your account details, please obtain details from our internet banking platform or mobile banking application, contact customer service hotlines or an HSBC branch)

#### Example:

USD payment to USD integrated savings account, beneficiary account example = 000123456151 (without exchange)

# Beneficiary account number crediting a current account or statement savings accounts in HSBC Macau as below:

- MOP current account, i.e. account with suffix 001, may involve exchange if the original payment is not in MOP.
- MOP statement savings account, i.e. account with suffix 091, may involve exchange if the original payment is not in MOP.
- HKD current account, i.e. account with suffix 101, may involve exchange if the original payment is not in HKD.
- HKD statement savings account, i.e. account with suffix 095, may involve exchange if the original payment is not in HKD

# Example:

HKD payment to HKD statement savings account, beneficiary account example = 000123456095 (without exchange and HKD Savings account is already opened)

SGD payment to MOP statement savings account, 000123456091 (with exchange and MOP Savings account is already opened)

GBP payment to HKD current account, beneficiary account example = 000123456101 (with exchange and HKD Current account is already opened)

#### Reference 2:

Account number of HSBC Macau must be 12 digits. Branch code is the first 3 digits and the following 9 digits are account number. You may check the account details through our internet banking platform or mobile banking application, contact our customer service hotlines or any HSBC branch.

#### Reference 3:

If your account name exceeds the number of characters supported by remitting banks, please continue the input in the beneficiary's address field.
